IMPORTANT NOTICE

The Horseback Riding Trail Beside the Road at Lake Tamarack Dam is CLOSED.

A recent State inspection of Bent Tree's Lake Tamarack dam addressed, among other things, the condition of the dirt horse/walking trail next to the paved road crossing the dam. The report noted that corrective action is needed to prevent further erosion. Until corrective action (path covered using crush n' run, wood chips, etc.) is taken that is satisfactory to the State, we must only ride on the pavement when crossing the dam. Bent Tree is working on a solution to this problem which will require the Board approving necessary funding. I will keep you posted as to when a corrective solution is in place and the trail is open for horseback riding. Remember, do not ride across any grass/dirt portion of the dam; ride on the pavement or use the Kentucky Derby trail in the woods. If you have any questions, please contact me.

Bent Tree Saddle Club - Executive Committee Consolidated Meeting Minutes 4/12/22

Meeting called to order by Judie Uchitel at 6:40pm

1. Minutes - reviewed and approved.

2. Treasurers Report

- Joyce Delay reported that the current balance is \$3908.

3. Membership Report

- Bob Crowl report that there are 91 members. New application for Cindi McLeod reviewed. Judie Uchitel made a motion to approve the application; motion was seconded and approved.

4. Agenda Items

Upcoming Calendar Events

- **Play Day reminder** tomorrow will be an obstacle event that Judie has already set up. Ronda has sent a reminder to help increase attendance.
- **Dawson Ride** April 23rd is the Dawson ride led by Joann Hartin. Joann has sent a reminder note to be forwarded to the club by Ronda Erway.
- Chickamauga Ride Ronda Erway volunteered to lead a Memorial Day weekend trailering ride Saturday, May 28th. A number of members have already expressed interest in attending. The date was added to the calendar and an article will be published in the next newsletter.
- **3rd Omoksee** Judie Uchitel reported that the date for a 3rd Omoksee is still pending Claire Eubanks scheduling approval.

New Business

- New Rules for riding horses over the BT Dam Bob Crowl reported that due to some potential for erosion during a BT dam inspection, the BT administration had changed some rules. When riding horses over the dam, horses are to remain on the road and not use the trail adjacent to the road until modifications can be made to prevent trail erosion.
- ECHO articles Kathy Hardin questioned who will do BTSC articles for the ECHO now that Julia Jorns is no longer a member. After discussion, Christine Cobb volunteered.
- Jump stands and post repair Judie Uchitel reported that jump posts and rails are in need of repair; mostly paint. After discussion, a work day will be added to the calendar Saturday, June 18th to make these repairs. Kathy Hardin made a motion to spend up to \$100 on paint and supplies to repair the jump posts and rails. The motion was seconded and approved.
- PVC ground rails Judie Uchitel reported that the PVC rails that were stored under the judge's stand are gone. They are not located in the barn or storage room. Should these not be located after further investigation, BT administration will be notified.
- Newsletter articles due April 24th.
- BTSC sign repairs Bobby Delay reported the sign for the arena is being repaired and should be reinstalled within the next week.
- EFS ride article Kathy Hardin volunteered to write an article for the newsletter regarding a recent group doing a ride at the EFS.
- Addition of more local ride days Kathy Hardin requested that a few more local rides be added to the calendar.
 After discussion, A Sharp Top ride was added for April 30th and a Songbird ride was added for May 21st.
 Both will be added to the calendar and a notice placed in the next newsletter.
- Summer Events Potential summer events to be investigated are: a Kayaking Trip on the Chestatee River with DJ Suburk's help, a BT Lake Party and the 4th of July Parade. Rose Rhys is considering coordinating the Parade and will be contacting Judie Uchitel should she decide to take on this challenge.
