- **BTSC Arena Awards Cover Replacement** Kathy Hardin has been working on getting the cover repaired/ replaced. Judie Uchitel will call Jim Sylvia directly to see if he would consider doing the repair.
- **Interest in Speakers** The group discussed whether there might be member interest in having educational speakers do events again. Kathy Hardin suggested sending out a poll to the membership to gauge interest and topic suggestions.
- Large Group Ride Concerns the group discussed some concerns that were expressed at the beach party regarding group rides. Some options were discussed and will be summarized and written up in an article for the newsletter by Ronda Erway.
- Encourage Social Members to Attend Arena Events As a means of increasing social time, social members will be reminded that attending arena events as spectators is a great way to participate and 'visit'. Judie Uchitel will ask Claire Eubanks to make a special note in the next Omoksee article to have social members come and watch and join us for lunch.
- Arena Treatment and Maintenance Judie Uchitel has been trying to treat the arena growth with chemicals alone. This is a monumental task that requires dragging to bring up dead/dying roots systems. Bob Crowl will work with Ronda and Randy Erway to get the chemicals to treat the arena. They will then coordinate using the Erway's spraying equipment to help treat the current growth and then use the BTSC drag to work the arena over the next couple of weeks.

We all worry about safety when riding for ourselves and our horses. Over the past year, I have heard a number of club members express concern about riding in a group. That means poor attendance at local and trailering rides. Unfortunately, this means no social time either. - Have people leave in smaller groups at 10-15 min intervals. This way people can ride with like minded riders and still socialize at lunch time.
