# **Upcoming Events**

#### Garland Mountain Ride Sunday, October 13<sup>th</sup>

Friends of Garland Mountain keep these trails pristine, and they recently just finished another weekend of work and replaced the old picnic table at the bottom of Sorrel.

Plan to arrive at the parking lot by 10:00am and ride out by 10:30am. We'll tentatively plan to return to the parking lot around 1:30pm. This is a ride with a gathering afterward. So, bring an appetizer to share, your drink preference and a camp chair!

The plan is for everyone to park in the dirt circular area on the right side when you first pull in. We'll pull around and form a circular area. Jim and I will bring a table that we will set up in the middle to put the food on when we return.

I will be leaving the trail head at 10:30. Assuming trails are in good condition with little rain, the current plan/route is to take Palamino to Buckskin to greenway to Chestnut. Depending on time, we'll then either take Roan, or start back on greenway to Dapple to Ellen's way and up Sorrel back to the trailers. If you want to ride on your own, or break out into faster or slower groups, that is great too. Just plan on being back for gathering after!

### Jake Mountain Ride Recap Thursday, September 19<sup>th</sup>


